Minutes of the meeting of Thornton Curtis Parish Council held on Monday 7th January 2013 in the Thornton Hunt Inn.

- 1. To Note Apologies for Absence Cllr C Couch, Ferry Ward Cllrs D Wells and P Clark.
- 2. To Note Declaration of Interest None
- 3. To Receive Public Participation There were no members of the public present.
- 4. <u>To Resolve the Minutes of the Previous Meeting</u>. The minutes of the meeting held on 5th November 2012 were amended at item 7 to read "Mrs Leach suggested there should be a newspaper article.." then proposed and signed as a true and correct record.
- 5. To Resolve Matters Arising.
 - i. Hilly Pits|" Cllr Davey and Cllr Leach suggested that as the water levels within the hilly pits had reached the highest levels since 2007, this be minuted so that a record was held of the event. It was agreed the clerk should request the Highways/Environment Team to view the site to learn more about the drainage within the village and the role the hillypits play in taking surface, highways and land drainage wateraway from the village.
 - ii. Northfield Farm The Clerk is to contact the Planning Dept to see if permission is needed for storage of static caravans and prefabricated offices at Northfield Farm.
 - iii. Archives. Clerk to trace minutes from 1982 2006.
 - iv Electricity Pole. This has been moved. Clerk to request NL Council to put a replacement "No Dog" sign on the new pole.
 - v. Issue of gas in the village. Cllr Grainger has 14 households signed up; details have been forwarded to British Gas but there has been no reply to date.
 - vi Salt bin for Burnham Lane. The bin is in place, and extra gritting salt delivered.
 - vii 30 mph road signs. The faded sign has still not been replaced.
 - viiiParking in Main Street. This has been resolved.
 - ix BCCRP. The correspondence has been archived, Cllr Brixton to pursue.
 - x Bus Service petition. An 8-10 seater minibus will run a return service from Barrow. Clerk to write and thanks Mr Hewitt, accepting the proposals and enquire if the bus could leave 10-15 minutes later from Barrow. Cllr Tulloch agreed to write a newsletter article; clerk to do advertising posters once the start date is known.
 - xi Footpath to Wootton. Cllr Brixton and Clerk had met with Neighbourhood Services to discuss clearing the middle section of path, no further update has been received on when this is scheduled for. Agenda item for next meeting to ask Ward Cllrs what their progress is on this matter.
 - xii Church floodlighting. Cllr Whelpton proposed the Council should only pay a set amount of £80/annum towards the floodlighting. Seconded by Mrs Leach and resolved. Cllr Tulloch agreed to liaise with the PCC and report back for the next meeting.
 - xiiiThe date for the public enquiry on the proposed wind farm at Horkstow has been set for 19th February at Elsham Hall.

6. To resolve Police Matters.

- i. Ferry NATs. Cllr Grainger will attend the next meeting on 21st February. To be on the agenda for the next meeting.
- ii Speed Sign data. The police do not intend to implement a speeding enforcement strategy following analysis of the speed sign date. It was agreed that the best way to push for action to be taken was via attendance at the NATs meeting.
- iii Police prioritising of crime in rural areas. Cllr Davey spoke of numerous recent break-ins and his concern that rural crime receives very low priority from Humberside Police. Unanimously resolved to write a complaint to Matthew Grove, Cllr Davey will write a draft letter, and also give a copy to Cllr Grainger for the NATs meeting.
