Minutes of the meeting of Thornton Curtis Parish Council held at 8.00 pm on Monday 11th March 2013 in the Thornton Hunt Inn.

- 1. Apologies for Absence Cllr A Tulloch, Cllr S Leach, Ferry Ward Cllrs P Clark and D Wells.
- 2. To Note Declaration of Interest None
- 3. <u>To Receive Public Participation</u> There were no members of the public present
- 4. <u>To Resolve the Minutes of the Previous Meeting</u>. The minutes of Monday 7th January 2013 were proposed as a true and correct record by Cllr Whelpton, seconded by Cllr Davey and resolved.
- 5. <u>To Resolve Matters Arising.</u>
 - Hilly Pits. Clerk is to contact the Highways Department regarding potential issues with drainage, and also to see if a safety barrier should be installed between the road and pits.
 - ii Northfield Farm. A planning officer has visited, and will monitor the situation regarding storage of portacabins.
 - iii. Archives. Ongoing.
 - iv. Issue of gas in the village. Cllr Grainger reported that the forms have gone off, and this is in hand.
 - v 30 mph road signs. Concluded, though some signs still obscured by hedges.
 - vi BCCRP. Cllr Brixon gave an update Mr Gathercole, Chair of BCCRP, has agreed to take up the issue of the cancelled train; "Railway Rambles" pack of circular walks in this area will be distributed shortly; The Easter Special will run on 30th March; Thornton Curtis station sign was stolen but has been retrieved and re-fixed.
 - vii Bus Service/Minibus. The new minibus system is running well.
 - viii Footpath to Wootton. Correspondence was received from Transport Dept asking for numbers of people who would walk a new footpath, ad their reasons for doing this. Cllr Grainger agreed to put a piece in the village newsletter asking for information.
 - ix Church floodlighting. The PCC are currently looking into changing the type of floodlighting bulbs, this was deferred until the next meeting in Cllr Tulloch's absence.
 - x Horkstow Wind Farm. The Preliminary Inquiry has take place, Clerk to check on the website to see what the next stage is.
 - xi Dog prohibition sign for play area. Cllr Whelpton agreed to fix the sign up.
 - xii College Road polytunnels. The planning officer will visit next week. Clerk to follow up.
 - xiii Gladwin's Farm sign. This will be erected shortly.

6. To resolve Police Matters.

- i. Ferry NATs meeting. Clr Grainger attended, and expressed the parish council's appreciation over action taken on the parking problems in Main Street. There were no issues in this area, thefts of iron and metal are down, current hotpspot is Killingholme and the problems with foreign HGVs. Cllr Grainger agreed to attend the next meeting.
- ii Letter to Matthew Grove. Cllr Davey has this in hand.
- iii. Neighbourhood Watch. There has been no response to the appeal for a co-ordinator. It was agreed to put an occasional article in the newsletter to keep this ticking over.

- Potholes. Thornton Road has been patched but the overall condition of the road is dangerous due to the surface being continually broken up by HGVs.. Clerk was requested to consult the Highways Dept on the feasibility of a weight restriction.
